SUBJECT: **RESCHEDULED FOR SEPTEMBER 10, 2018**

**Joint-Reorganization and Associated Sphere Amendments |
Concurrent Dissolution of the Julian-Cuyamaca Fire Protection
District and Latent Power Area Expansion of County Service
Area No. 135 (County Fire Authority); File No. RO18-09 et al.**

The San Diego Local Agency Formation Commission (LAFCO) has rescheduled this public hearing for the joint-reorganization proposal filed by the Julian-Cuyamaca Fire Protection District (FPD) and County Service Area (CSA) No. 135 to a special meeting on Monday, September 10, 2018. The special meeting will start at 9:00am at the County Administration Center's Board Chambers. The rescheduling will allow LAFCO staff to re-notice the hearing and remedy system errors discovered in the mail-out that generated an unacceptable number of returns. Rescheduling to September 10th represents the next date in which a majority of the Commissioners are available and avoids over-calendaring the next regular meeting on October 1st. It also continues to comply with the statutory deadline to hold the hearing under LAFCO law.¹

A copy of the Executive Officer's written report with recommendations on the reorganization was posted online on July 17th. The report remains available online and will be presented with updates to reflect new dates at the rescheduled hearing on September 10th.

¹ San Diego LAFCO issued a Certificate of Filing for the reorganization proposal on July 18, 2018. Under Government Code Section 56658 this obligates the Commission to proceed with scheduling a hearing with the statutory expectation it occur at the next meeting that notice can be provided and no later than 90 days. The latter deadline requires the Commission conduct the hearing on the reorganization proposal no later than October 16, 2018.
