EXECUTIVE OFFICER'S UPDATE

On January 25th, Commissioner Andy Vanderlaan, LAFCO Consultant Harry Ehrlich, and Michael Ott met in Santa Ana with a group of LAFCO staff and commissioners from Southern California who formed a new organization (Coalition of California LAFCOs) to represent the diverse interests of LAFCOs in the southern part of the state. Topics discussed at the January 25th meeting included separation from CALAFCO, development of by-laws, review of a proposed legislative program; and strategy for meeting with CALAFCO representatives.

The Coalition of California LAFCOs (CCL) established a monthly meeting schedule and decided to meet in San Diego on February 16th. Executive Officer Michael Ott will be hosting the meeting. Topics scheduled for discussion at the February meeting include the review of draft by-laws; timeline for formal establishment of the coalition; discussion of pending legislation; announcement of educational opportunities; establishing a

future meeting schedule; and developing an outreach plan with CALAFCO.

On February 19th and 22nd, the San Diego LAFCO's Special Districts Advisory Committee and Ad hoc Cities Advisory Committee will be meeting to discuss a proposed jurisdictional conflict policy.

On February 19th, the Task Force on Fire Protection and Emergency Services will be meeting at the County Administration Center.
