EXECUTIVE OFFICER'S UPDATE

On January 19th, Commissioner & Supervisor Dianne Jacob convened an emergency services meeting in her El Cajon district office for residents residing on Rio Maria Road. This area is an unserved fire service island bisected by Highway 67 and Rio Maria Road. The area receives emergency service from a number of fire agencies on a voluntary basis. Commissioner Jacob is exploring options to secure a more reliable method of service. Executive Officer Michael Ott and Chief Analyst Shirley Anderson assisted Commissioner Jacob with this community meeting.

The Special Districts Advisory Committee will meet on February 19th, to discuss the Commission's proposed jurisdictional conflict policy. A meeting will also be held by LAFCO's Cities Advisory Committee on February 22nd.

On January 25th, Commissioner Andy Vanderlaan, LAFCO Consultant Harry Ehrlich, and Michael Ott will

meet in Santa Ana to discuss CALAFCO's proposal to regionalize representation on the statewide executive board. For the past year, Michael Ott has been working with a coalition of LAFCO staff and commissioners to develop a plan to expand Southern California's representation on the CALAFCO governing board.
