SUBJECT: Service Commendations

Former Commissioners Blakespear, Sprague, and Hanson (alt)

SUMMARY

The San Diego County Local Agency Formation Commission (LAFCO) will recognize the service contributions of three former members – regulars Catherine Blakespear and Ed Sprague and alternate Judy Hanson. This recognition follows the members' recent departure from the Commission as a result of their terms ending and involves the adoption of resolutions of commendation for future presentation off dais. Recommend approval.

BACKGROUND

Commission Composition

San Diego LAFCO's governing body consists of 13 Commissioners divided between eight regular and five alternate members. Members are drawn from five distinct membership categories prescribed under statute as detailed below.

 Three members are appointed by the County of San Diego Board of Supervisors among its ranks and divided between two regulars and one alternate.

- Three members are appointed by the City Selection Committee (mayors) among their ranks and divided between two regulars and one alternate.
- Two members are appointed by the City of San Diego Council among its ranks and divided between a regular and alternate.¹
- Three members are elected by the Independent Special District Committee (board presidents) among its ranks and divided between two regulars and one alternate.
- Two members of the general public are appointed by the other four membership categories on the Commission and divided between a regular and alternate.

All seats on the Commission are four-year terms. Terms go with the seat and not the Commissioner. Accordingly, if a Commissioner leaves early, the successor appointee assumes the unexpired term. Appointees may also serve beyond their terms and until the appointment and qualification of their successors.²

DISCUSSION

This item is for San Diego LAFCO to take action to formally recognize the service contributions of three former Commissioners upon their recent terms ending on May 5, 2019. The three past Commissioners are Catherine Blakespear with the City of Encinitas, Ed Sprague with the Olivenhain Municipal Water District, and Judy Hanson (alternate) with the Leucadia Wastewater District. Recognition includes adopting the attached draft commendation resolutions for future presentation off dais by staff.

ANALYSIS

All three past members – Catherine Blakespear, Ed Sprague, and Judy Hanson (alternate) – served with distinction and regularly contributed to advancing the work of the Commission. Adopting commendation resolutions serve to officially memorialize the recognition to all three members as part of LAFCO's official records.

RECOMMENDATION

It is recommended San Diego LAFCO formally recognize the service of Catherine Blakespear, Ed Sprague, and Judy Hanson (alternate) and adopt resolutions of commendation consistent with the actions identified in the proceeding section as Alternative One.

¹ The two seats dedicated to the City of San Diego is the result of special legislation and specific to ensuring the municipality with the largest population in San Diego County has ongoing representation on LAFCO.






