

**Purpose for Notice:** The City of San Marcos is requesting written feedback from the public, interested organizations, and responsible and trustee agencies about the scope and content of the environmental information that will be addressed in the draft Environmental Impact Report (EIR). The EIR will address the environmental issues discussed in the project's initial environmental study that can be found on the City's website at <a href="https://www.san-marcos.net/highlands">www.san-marcos.net/highlands</a>.

All written comments must be submitted within 30 days of this notice and received no later than September 15, 2014. Please submit all comments to Associate Planner Norm Pedersen via email, npedersen@san-marcos.net or letter mailed to the City of San Marcos Planning Division, 1 Civic Center Drive, San Marcos, CA 92069.

Project Description: The applicant has proposed 189 clustered single-family residential lots on 262 acres at the northern end of Las Posas Road along with an additional 26 acres of open space on an adjacent property to the northwest. The project also proposes annexation of 121 acres, or a portion thereof, from the County of San Diego approval by the Local Agency Formation Commission (LAFCO). A pre-zone from County Zoning (A-70) to Specific Plan Area (SPA) will be required for a 9.7-acre portion of the project site currently in the County.



Additionally, a Ridgeline Development Permit that would allow a portion of the proposed subdivision to be developed within the Ridgeline Overlay Zone and a Conditional Use Permit for temporary use of a rock crusher(s) during grading operations has been requested. The extension of North Las Posas Road to Buena Creek Road is not proposed as part of this project.

Property Location: North of Santa Fe Hills at the northern end of North Las Posas Road.
