## SAN DIEGO COUNTY LOCAL AGENCY FORMATION COMMISSION NOTICE OF PUBLIC HEARING

Notice is hereby given the San Diego County Local Agency Formation Commission (“LAFCO”) will hold a virtual public hearing on **Monday, April 5, 2021 at 9:00 a.m.** with Commissioners participating remotely utilizing video and teleconference technologies consistent with the Governor’s Executive Orders for physical distancing due to the COVID-19 pandemic. At the virtual public hearing, LAFCO will consider the following matter:

### **PROPOSED “PLUMOSA AVENUE REORGANIZATION” CONCURRENT ANNEXATION TO CITY OF VISTA AND DETACHMENT FROM VISTA FIRE PROTECTION DISTRICT WITH CONFORMING SPHERE OF INFLUENCE ACTIONS LAFCO FILE NO. RO20-18 et. al**

During the public hearing, LAFCO will consider the reorganization proposal filed by resolution of the City of Vista involving the principal action to annex one unincorporated parcel totaling 0.7 acres within the City sphere. A secondary action is also proposed to detach the unincorporated parcel from Vista Fire Protection District. Modifications to the affected territory may be considered by LAFCO as well as conforming of sphere of influence amendments. The purpose of the proposal is to facilitate the connection of public wastewater service in response to the existing single-family residence’s failing septic system.
