# d) Proposed "Chinese Bible Church Change of Organization" | Annexation to the Rancho Santa Fe Community Services District (CO20-22) (action)

The Commission will consider a change of organization proposal filed by an interested landowner to annex approximately 9.1 unincorporated territory to the Rancho Santa Fe Community Services District. The affected territory includes one developed parcel with an existing single-family residence along with a detached guest house in the unincorporated community of Santa Fe Valley north of the City of San Diego. The proposal purpose is to extend public wastewater service to the subject parcel and facilitate the planned development of a religious facility and accessory structures. Staff recommends conditional approval of the proposal without modifications along with waiving protest proceedings. The subject parcel is identified by the County of San Diego Assessor's Office as 678-060-27. (Pages X-Y)

# e) Proposed "Estrada-Viejas View Place Change of Organization" | Annexation to the San Diego County Sanitation District (CO20-20) (action)

The Commission will consider a change of organization proposal filed by an interested landowner to annex approximately 1.0 unincorporated acres to the San Diego County Sanitation District. The affected territory includes one parcel in the Alpine community previously developed with a single-family residence that was destroyed in a recent wildfire event. The proposal purpose is to permanently extend public wastewater service to accommodate a rebuilt single-family residence as well as an accessory dwelling unit and in doing so replace a temporary out-of-agency service agreement approved by LAFCO in February 2021. Staff recommends conditional approval of the proposal without modifications along with waving protest. The subject parcel is identified by the County of San Diego Assessor's Office as 404-200-24. (Pages X-Y)

# f) Proposed "Huelsman–Acacia Avenue Change of Organization" | Annexation to the San Diego County Sanitation District (CO20-23) (action)

The Commission will consider a change of organization proposal filed by an interested landowner to annex approximately 0.5 unincorporated acres to the San Diego County Sanitation District. The affected territory includes one parcel developed with an existing single-family residence in the unincorporated community of Bonita. The proposal purpose is to extend wastewater service to the subject parcel as a preventive measure to replace an aging septic system. Staff recommends conditional approval of the proposal with a modification to include 0.06-acre frontage portion of Acacia Avenue to the centerline along with waiving protest proceedings. The subject parcel is identified by the County of San Diego Assessor's Office as 594-051-09. (Pages X-Y)

# a) Proposed "Meadowood Reorganization" | Concurrent Annexation to Rainbow Municipal Water District with Detachment from Valley Center Municipal Water District and Conforming Sphere of Influence Amendments (RO20-10 et al.) (action)

The Commission will consider a reorganization proposal filed by Rainbow Municipal Water District with the principal action to annex 266.9 unincorporated acres in northern Valley Center. A concurrent detachment from Valley Center Municipal Water District is also proposed. The proposal purpose is to facilitate the planned development of a 844-unit residential subdivision – "Citro" (formerly Meadowood) – through the extension of public water and wastewater services and would supersede an existing outside service agreement between the subject agencies. Staff recommends conditional approval of the reorganization with conforming sphere of influence amendments as well as waiving protest proceedings. The subject parcels are identified by the County of San Diego Assessor's Office as 108-120-52, 108-120-53, 108-120-54, 108-121-15, 108-122-03, 108-122-09, 108-122-09, 108-122-15, 108-122-19, 125-061-04, 125-061-07, and 125-062-07. (Pages X-Y)

### b) Adoption of a Final Workplan and Budget for 2021-2022 (action)

The Commission will consider recommendations from the Executive Officer in adopting a final workplan and budget for 2021-2022. The final workplan is identical to the earlier draft and outlines 30 specific project goals ranging in priority from "high" to "low." The final budget is substantively identical to the earlier draft with revisions limited to internal adjustments with overall expenses remaining at \$1.941 million, which is 1.3% higher than the current fiscal year. A matching amount of revenues are also budgeted with one internal distinction to set agency apportionments at current levels with the remaining difference being covered by additional reserves. Recommendation to approve both documents by resolution. (Pages X-Y)
