Notice is hereby given the San Diego County Local Agency Formation Commission (“LAFCO”) will hold a virtual public hearing on **Monday, June 7, 2021 at 9:00 a.m.** with Commissioners participating remotely utilizing video and teleconference technologies consistent with the Governor’s Executive Orders for physical distancing due to the COVID-19 pandemic. At the virtual public hearing, LAFCO will consider the following matter:

MUNICIPAL SERVICE REVIEW ON THE POWAY REGION FINAL REPORT AND DETERMINATIONS

In accordance with Government Code Section 56430, LAFCO will open a public hearing to consider actions involving the final report and recommendations therein prepared by staff as part of the agency’s scheduled municipal service review on Poway region with specific focus on the City of Poway. The final report follows the earlier circulation of a draft report in April 2021 and focuses on independently assessing the availability, capacity, and performance of public services subject to LAFCO oversight. The report is intended to serve as the source document in informing separate and/or future actions to update spheres of influence, approve boundary changes, and/or order reorganizations. LAFCO will consider actions to accept the final report and adopt a resolution codifying the associated determinations as required under State law. The draft municipal service review includes an Executive Summary outlining key conclusions and recommendations identified to date by LAFCO staff. A draft report is available for viewing and the final version is expected to be available online at www.sdlafco.org no later than May 28, 2021. The public is encouraged to review all materials relating to the municipal service review and attend the public hearing on Monday, June 7th.
