SUBJECT: Commission Ratification

Recorded Payments for July and August 2021

SUMMARY

The San Diego County Local Agency Formation Commission (LAFCO) will receive a report identifying all payments made and received in July and August 2021. The payments cover all recorded transactions for the two-month period and include \$312,402 in total distributions made by the Executive Officer. Two thirds of these expenses are tied to the County of San Diego for payroll reimbursements and charges for office rent, general overhead, and information technology services. Payments received over the two-month period totaled \$1,662,763 and largely sourced to collecting local agency apportionments. The payments are being presented to the Commission for formal ratification.

BACKGROUND

Accounting Policies and Procedures

San Diego LAFCO's policies provide direction to the Executive Officer to establish and maintain appropriate accounting controls for all financial transactions on behalf of the Commission. These policies specify the Executive Officer shall ensure accounting controls conform to standard procedures commonly enlisted by local governmental. Spending allowances are specified and include bid procedures for financial transactions at or above \$10,000 and separate Commission approval for transactions at or above \$125,000.

DISCUSSION

This item is for San Diego LAFCO to consider ratification of all payments made and received by the Executive Officer between July and August 2021. A detailing of these transactions prepared by the Administrative Assistant is provided in Attachments One (July) and Two (August). The item also provides the Commission the opportunity to provide feedback on related matters and inform potential changes in accounting procedures going forward.

ANALYSIS

San Diego LAFCO's recorded payments made by the Executive Officer for July and August 2021 totaled \$312,402 with 65% – or \$201,958 – tied to transactions with the County of San Diego. This includes payroll reimbursements covering four pay periods as well as expenses for office rent, general overhead, and information technology services. Office expenses represent most of the remaining costs during the two-month period with \$47,104 directly tied to furnishing the new office space at 2550 Fifth Avenue through a single vendor, National Business Furniture. Recorded revenues during the period totaled \$1,662,763 with the majority of funds tied to collecting agency apportionments.

All expenses generated in July and August 2021 are consistent with the adopted budget with one deviation. This deviation involves the above-referenced furniture expense for the new office space paired with a limited number of other one-time moving costs. All monthly total transactions for the calendar year to date are shown below.
