Attendance by videoconference via live-streaming will also be allowed to accommodate additional physical distancing due to the COVID-19 pandemic. At the public meeting, LAFCO will consider the following public hearing matter:

SPHERE OF INFLUENCE UPDATE:
RAMONA MUNICIPAL WATER DISTRICT

In accordance with Government Code Section 56430, LAFCO will open a public hearing to consider taking formal action to update the sphere of influence designations for the Ramona Municipal Water District (MWD) covering all of its active service functions. This includes updating both the primary and secondary designations with the latter category having been established to cover only wastewater services. An associated municipal service review on the Ramona region with specific focus on the Ramona Municipal Water District serves as the source document in informing the update and is available for viewing online at www.sdlafco.org. The agenda report on the item with specific recommendations - including an anticipated recommendation to expand the primary sphere to include properties along Cloudy Moon Drive and Dos Picos Park Road - will be available online by October 22, 2021. The public is encouraged to review these materials and attend the hearing on Monday, November 1st either in person or by videoconference.
