Notice is hereby given the San Diego County Local Agency Formation Commission (“LAFCO”) will hold a public meeting on Monday, December 6, 2021 at 9:00 a.m. at the County of San Diego Administration Center at 1600 Pacific Highway, Room 302, San Diego, California. Attendance by videoconference via live-streaming will also be allowed to accommodate additional physical distancing due to the COVID-19 pandemic. At the public meeting, LAFCO will consider the following public hearing matter:

During the public hearing, LAFCO will consider the change of organization proposal filed by a joint-landowner petition involving approximately 1.5 acres of unincorporated territory within the unincorporated community of Fallbrook. The proposed change of organization’s purpose is to facilitate the extension of public wastewater services to two adjacent parcels to accommodate existing and planned uses therein. Concurrent action to amend and expand Fallbrook Public Utility District’s secondary sphere of influence (wastewater function) will also be considered at the hearing.
