NOTICE OF PUBLIC HEARING

Notice is hereby given the San Diego County Local Agency Formation Commission (“LAFCO”) will hold a public meeting on **Monday, June 6, 2022 at 9:00 a.m.** at the County of San Diego Administration Center at 1600 Pacific Highway, Room 302, San Diego, California. Attendance by videoconference via live-streaming is also anticipated to accommodate additional physical distancing due to the COVID-19 pandemic. At the public meeting, LAFCO will consider the following public hearing matter:

**PROPOSED “RAMONA MUNICIPAL WATER DISTRICT REORGANIZATION”
 DIVESTITURE OF FIRE PROTECTION AND EMERGENCY MEDICAL SERVICE FUNCTIONS AND
 CONCURRENT ANNEXATION TO SAN DIEGO FIRE PROTECTION DISTRICT**

During the public hearing, LAFCO will consider the reorganization proposal filed by resolution of the Ramona Municipal Water District (MWD) involving approximately 46,005 acres of unincorporated territory within the Ramona region. The proposed reorganization involves a concurrent request by Ramona MWD to divest itself of fire protection and emergency medical service functions within its jurisdictional boundary and transfer these functions via annexation to the San Diego County Fire Protection District (FPD) as the successor agency.

Documents regarding the reorganization proposal item will be available for viewing online at www.sdlafco.org no later than 96-hours before the scheduled hearing. The public is encouraged to review these materials, provide comments, and attend the public hearing on Monday, June 6th. Additional details on public participation and submittal of comments are also available at the LAFCO website. Importantly, should LAFCO approve the proposal, a subsequent protest hearing for all landowners and registered voters within the affected territory will be separately noticed.
