



NOTICE OF PUBLIC HEARING

Notice is given the San Diego County Local Agency Formation Commission (“LAFCO”) will hold a public meeting on **Monday, February 5, 2024 starting at 8:00 a.m.** at the County of San Diego Administration Center at 1600 Pacific Highway, Room 302, San Diego, California. At the public meeting, LAFCO will consider the following public hearing matter:

**- PROPOSED “CITY OF CARLSBAD CHANGE OF ORGANIZATION” -
 DETACHMENT FROM LEUCADIA WASTEWATER DISTRICT AND CONCURRENT SPHERE OF INFLUENCE ACTION
 LAFCO FILE NO. CO23-09**

During the public hearing, LAFCO will consider the above-cited change of organization proposal filed by resolution of the City of Carlsbad. The proposed change of organization involves the detachment of incorporated territory located within the City of Carlsbad consisting of three non-contiguous areas from the Leucadia Wastewater District. The purpose of the proposed change of organization is to eliminate an existing overlap between two public wastewater service providers and align the respective service areas consistent with the existing infrastructure. The proposal also necessitates a conforming sphere of influence amendment to Leucadia Wastewater District to exclude one area of the affected territory and necessitates consideration as part of a noticed hearing.

Documents regarding the change of organization proposal – including a map of the proposed affected territory – are available for viewing online at www.sdlafco.org now and will include posting of the staff report and recommendation no later than 96-hours before the scheduled hearing. The public is encouraged to review these materials and provide comments.
