SUBJECT: **Appointment of an Alternate Public Member and Related Actions**

SUMMARY

The San Diego County Local Agency Formation Commission (LAFCO) will consider a recommendation from its Alternate Public Member Recruitment Committee (Whitburn, Willis, and White) to fill an unexpired term through April 2027. The recommendation follows the Commission’s action in March to create and task the Committee to conduct an open recruitment to fill the alternate seat following the promotion of Commissioner Mathis to the regular seat. Eight candidates have been considered by the Committee with two receiving invitations to interview. Drawing from this process, the Committee unanimously recommends the Commission appoint Bridgette Browning. A successful appointment requires a majority vote among the other four membership categories (County of San Diego, City of San Diego, cities, and special districts) with at least one affirmative vote from each category. It is also recommended the Commission formally dissolve the Committee.

BACKGROUND

Membership Composition

San Diego LAFCO's membership is prescribed under State law to include 13 appointed Commissioners. The Commissioners are divided into five distinct categories – County of San Diego, cities less City of San Diego, City of San Diego, special districts, and the general public – and further distinguished between regular and alternate members. Only the public member category and its regular and alternate appointees are made by LAFCO; the appointments for the other four categories are externally determined under the statute.

Membership Terms

All terms are four years and commence on the first Monday in May in the affected year. There are no term limits involving LAFCO appointments in statute or under local policy.

Alternate Public Member Vacancy + Commission Action Creating an Ad Hoc Committee

San Diego LAFCO's alternate public member position became vacant on March 4, 2024 when the Commission appointed Harry Mathis to the regular seat following the resignation of Andy Vanderlaan.¹ Commissioner Mathis' appointment to the regular seat left the alternate seat open with an unexpired term running through April 2027.

The Commission took separate action on March 4th to create the Alternate Public Member Recruitment Committee consisting of Chair Whitburn, Vice Chair Willis, and Commissioner White. The Commission also authorized the Committee with discretion to recruit and advance one or more candidates for formal consideration at a future meeting.

DISCUSSION

This item is for San Diego LAFCO to consider the recommendation of the Alternate Public Member Recruitment Committee to appoint Bridgette Browning to the open term. The recommendation follows the Committee conducting an open recruitment beginning with posting announcements online and publishing in local newspapers inviting candidates to submit letters of interest by June 10th. A total of eight candidates applied by the deadline with one candidate voluntarily withdrawing. The seven remaining candidates were directly screened by the Committee with two receiving invitations to interview on July 24th. The Committee proceeded to interview one of the two final candidates – Bridgette Browning – with the other candidate canceling immediately prior due to a personal emergency. Given the strength of the candidate and their interview, the Committee agreed to proceed with advancing Ms. Browning to the full Commission as their unanimous recommendation.

¹ Mr. Vanderlaan served on the Commission since 1996 with the current four-year term extending through April 2025.

ANALYSIS

San Diego LAFCO has broad discretion in statute and policy in appointing a public member – regular or alternate. Statute only requires the appointment to follow notice to local agencies, the appointee be a resident of San Diego County, the appointee not be an employee or officer of a member agency (i.e., the County, cities, or special districts), and an affirmative vote is achieved by all appointing categories on the Commission. The Commission relatedly provided full discretion to the Committee to recruit, screen, interview, and recommend one or more candidates for Commission consideration at a future hearing.

As tasked, the Committee has performed an approximate four-month recruitment process with the assistance of the Assistant Executive Officer resulting in consideration of seven otherwise exceptionally qualified candidates. The Committee is unanimous in recommending Bridgette Browning based – and among other attributes – on her established and extensive ties throughout San Diego County and professional accomplishments as an executive of one of the largest labor organizations in California. A copy of Ms. Browning’s letter of interest and professional resume is provided as Attachment One.

RECOMMENDATION

It is recommended San Diego LAFCO take affirmative action on the Committee’s recommendation to appoint Bridgette Browning as the alternate public member. This recommendation is consistent with Alternative One provided in the proceeding section.

ALTERNATIVES FOR ACTION

The following alternative actions are available to San Diego LAFCO and can be accomplished with a single motion:

Alternative One:

- (a) Appoint Bridgette Browning as the alternate public member to an existing four-year term commencing immediately and terming on the first Monday of April 2027.
- (b) Dissolve the Committee.

Alternative Two:

Continue the item and provide direction to the Committee as needed.

PROCEDURES

This item has been placed on San Diego LAFCO's agenda as part of a noticed public hearing. The following procedures are recommended in the consideration of this item:

- 1) Disclose any material ex-parte communications.
- 2) Receive verbal presentation unless waived.
- 2) Open the hearing and invite public testimony.
- 3) Discuss the item and consider the recommendation or alternatives.
