SUBJECT: Fire and Emergency Medical Services Workshop

A LAFCO workshop covering fire and emergency medical services (EMS) is scheduled for February 2, 2015. The purpose of the workshop is twofold. First, it is hoped the workshop will provide information regarding the ongoing and emerging issues affecting the entire region with respect to fire protection and emergency medical services. Second, it is time to begin reviewing Commission priorities and strategies for 2015 and beyond. This will become especially important as LAFCO nears the completion of the current round of service reviews and begins developing a plan for the upcoming ones.

Since 2005, the County Board of Supervisors has taken a lead role on several actions to improve fire and emergency medical services in the unincorporated areas of San Diego County. On June 25, 2008 the Board initiated the implementation of the Hybrid Plan to improve fire and emergency medical services in three steps in unincorporated San Diego County. The Hybrid Plan reorganized multiple volunteer fire organizations and CSA's in Steps I and II. Steps I and II are complete; Step III involving the dissolutions of Pine Valley and Rural FPD's with subsequent inclusion in CSA 135's latent powers fire area is underway and will be considered by LAFCO within the upcoming months.

The County has adopted a five-year Fire Master Plan to serve as a strategic planning document for policy makers and executive management on operational, administrative and fiscal decisions pertaining to the San Diego County Fire Authority. The Fire Master Plan provides an assessment of the current state of the volunteer firefighter program, contracted fire services, apparatus, equipment and facilities, and identifies service needs over the next five years. The County of San Diego should be recognized for their collaborative efforts that have improved the delivery of fire and emergency medical services in the unserved and underserved regions of unincorporated of San Diego County. The Master

Plan provides a path for the San Diego County Fire Authority and partnering agencies to better assess the needs for fire protection and EMS, plus the sustainability of service delivery.

This February 2nd workshop is not an assessment of the accomplishment of the County of San Diego. It also will not focus on the ability of the region to adequately respond to major wildland or other major catastrophic events. Rather, the intent of the workshop is to place a focus on the sustainability of day-to-day fire and emergency medical operations. The workshop will also help to identify opportunities for collaboration and cooperation among all local government agencies that provide fire and EMS service. Workshop speakers will address ongoing funding constraints and service delivery cost issues that continue to challenge the sustainability of providing day-to-day services. It is hoped that the workshop will help policy makers, service providers, and LAFCO members to better identify and understand the many opportunities that are available to maximize resources, contain cost, eliminate duplication of effort -- while maintaining an acceptable level of local control and service.

In the past 25 years, the Commission's efforts and priorities have focused primarily on solving some of the most vexing jurisdictional issues, such as streamlining local government structure through the consolidation and reorganization of local fire agencies. Since 1988 alone, the San Diego LAFCO has consolidated, dissolved, or merged 93 special districts—a statistic that has set statewide records. Within the past five years alone, the San Diego LAFCO has dissolved five fire protection districts and placed over a million acres of unserved territory within the boundaries of a recently activated county fire protection agency. Two additional fire protection districts and one CSA are proposed for dissolution in 2015 in accordance with LAFCO's long-range fire protection plan. Additionally, one water district is also proposed for dissolution in 2015 – a level of jurisdictional activity that is unprecedented.

While the reorganization of local agencies will continue to be a LAFCO priority in the future, it is expected that this level of jurisdictional activity will taper off in the upcoming years. Therefore, the time has come to begin identifying and setting new LAFCO priorities and strategies to help identify ways to improve public services in the region. One of the strategies under consideration is to evaluate how well local agencies coordinate with each other and how agencies can pool certain key services and facilities to get the most out of limited resources. The February 2nd LAFCO workshop will help the Commission to better understand current trends and issues, as well as future strategies that can be used to encourage efficient service delivery while reducing redundancy and duplication of effort.

Presenters invited to the February 2nd workshop include: E. John Traylor, Local Government Consultant (San Diego LAFCO); William "Bill" Metcalf, Fire Chief of North County Fire Protection District and Past President, International Association of Fire Chiefs; Rick Sitta, Fire Chief Heartland Fire Rescue (three cities JPA with El Cajon, La Mesa and Lemon Grove); and David Ott, City Manager and Retired Public Safety

Director (City of Solana Beach). Please refer to the attached workshop program for further information.
